The children have thrived in their father's stable, loving home. Yet, according to court documents, their mother would without warning arrive from out of state, unexpectedly take the boys, and disappear for periods of time. Not only did this interfere with the children's schooling, but it also left dad frantic about his children's safety and well-being. Dad even went as far as to call the police, hoping to prevent the mother from taking the children without his permission, to no avail.

While dad was never against the boys seeing and spending time with their mother, he wanted the visits to be orderly and scheduled, not disruptive and stressful.
